The 193rd meeting of the Texas Surgical Society was held April 4-6 in El Paso, Texas at the El Paso Marriott Hotel under the direction of Local Arrangements Chair **Alan Tyroch** and his wife **Roxanne Tyroch**. Their coordinated efforts and the hospitality of the event chairmen generated a wonderful experience for the 72 members and 35 guests who participated in the weekend activities. Both Drs. Tyroch and their team were truly exceptional in organization, hospitality and expertise.

On Friday morning **Ed Saltzstein** directed the golf tournament at the **Butterfield Trail Golf Course**. **John Staub** of Midland was awarded both the Brindley Cup – Low Gross award and the Arlington Cup for Low Net.

Tennis under the direction of **Bruce Applebaum** was held at the **El Paso Tennis Club**. There were no women member participants. **Jack Walzel** from Round Rock took the Men's Waco Trophy.

Bill Miller organized the sporting clay shooting event at **the Fort Bliss Rod & Gun Club**. **John Winter** of Dallas was the winner of the Fort Worth Shooting Trophy.

Early Saturday morning **Bruce Applebaum** escorted our joggers to **McKelligon Canyon in the Franklin Mountains State Park**. **Laurens Pickard** from Houston was awarded the The San Antonio Cup for the fastest time. **Bruce Applebaum** from El Paso was awarded the Raleigh R. White Trophy.

The first Scientific Session was called to order by **President Shelton Viney** at 1:30 p.m. on Friday afternoon. He introduced **LAC, Alan Tyroch** who welcomed the membership to El Paso and

informed them of the many events planned for the weekend. **Mellick Sykes** started off the paper presentations with a talk on the publications of the Texas Surgical Society. Four additional paper presentations followed.

Treasurer Ross Reagan and **President Viney** then recognized the 2014 spring class of **Raleigh Ross Scholars**. Recipients were introduced by their Department Chair or Residency Program Director. Following presentation of the Raleigh Ross Scholars, President Shelton Viney introduced the honored guest speaker, **Dr. Michael J. Sise, Trauma Medical Director at Scripps Mercy Hospital**. **Dr. Sise** delivered an educational talk entitled “**Never be the first to adopt or the last to abandon any therapy or technique.**” Dr. Sise's well-received address delivered sage advice for the care of our patients.

The Executive Session began at 5:15 p.m. with **President Shelton Viney** presiding. Minutes of the previous meeting in Houston were unanimously approved.

The Treasurer's Report was presented by **Ross B. Reagan**. Total assets of the Society increased from \$108,187 at the end of 2012 to \$201,564 at year end 2013. The primary reason for this improvement in financial status was the increase in dues and initiation fees that were effective in 2013. Meeting expenses were unchanged year to year and there was minimal change in general expenses. Over \$10,000 in gifts to the Speakers Fund were received in 2013 and early 2014, including many generous memorial gifts for Marion Lawler, Ed Sykes and other deceased members.

The assets of Raleigh Ross Trust increased from \$2,351,367 at end of 2012 to \$2,725,722 at the end 2013, reflecting a good year for the stock market. In 2014 there will be 11 residency programs receiving grants from the Trust, with the Trustees adding to the grant program the residencies at Texas Tech-El Paso, Methodist Hospital-Houston, and UT Southwestern-Austin. Each of the 11 programs will receive an unrestricted grant of \$9,125 in 2014.

The Secretary then gave the report of the Council. Updates were given regarding plans for the Fort Worth meeting, where **Richard Vigness** is serving as the LAC. Plans regarding the Centennial Meeting in Galveston were discussed. **Dr. Kristene Gugliuzza** will serve as LAC. The Council received a report from Dr. Chuck Fraser regarding a recommendation to form a capital fund raising campaign. The Council approved moving forward with this plan. The Council reviewed the report given by the Ad Hoc Committee on Membership at the Temple meeting and identified areas to implement. The Council unanimously approved the policy on nondiscrimination:

“The object of the Society, ‘the advancement of the science of surgery’ must never be absent from our thoughts. Personal advancement and petty politics must have no place in our councils. Good work for the love of good work must be our motto. If we reach toward these ideals and retain supreme faith in our possibilities and powers, nothing can prevent our growth into a dignified learned Society that will be a power for good in our own state and an object of admiration to our neighbors.

Therefore:

The **Report of the Archivist** was given by **Mac Sykes**. He discussed the status of the archival material for the material for the Centennial meeting in Galveston. The next Twenty-Five Year review of the the TSS is under way and is planned to be published following the Centennial meeting.

Current membership statistics were reviewed. There are **549 members**, of whom **147 are active, 370 are senior, 5 are honorary, 4 are distinguished and 27 are non-resident members**. There were **3 deaths** recorded since the last meeting. The importance nominating quality surgeons was discussed. This was also a part of the ad-hoc committee on Membership, noted above. **Members are encouraged to propose candidates for membership who meet or exceed Society qualifications as outlined in the constitution and by-laws.**

The judges for the James E. Thompson award had a difficult time in choosing the best paper by a new member as all were excellent!

The Presidential Award for Discussion was awarded to **Robert W. Feldtman** of Dallas.

Members and guests joined **President Shelton Viney** after dinner for coffee, dessert and liquors.

The Ethics Breakfast was held at 8:00 a.m. Sunday morning. **Nick Houser** addressed the 43 attendees with a talk entitled "The World's 1st Public Health Campaign: 1804 Small Pox Vaccination". His talk was interesting and stimulated a significant discussion regarding the topic.
